**SUB: Election of Managing Committee of PRIA for the years 2024-2029**

Dear Sir,

The tenure of present Managing Committee of PRIA is up to 31<sup>st</sup> March 2025

However, pursuant to the byelaws amendment for extending Managing Committee tenure from earlier 2 years to 5 years as per the amendment order issued by the Charity Commissionerate on March 13, 2024 followed by the Managing Committee meeting decision on March 29, 2024 it has been decided to held election for Members of the Managing Committee for the years 2024-2029 as per (Para F) of Rules and Regulations of the Association.

Election will be conducted on following guidelines / rules.

- A) Managing Committee shall appoint Returning Officer after obtaining his consent, through concern Member Industry, which has paid Annual Subscription of the Association upto 31<sup>st</sup> March 2024. It will be responsibility of Returning Officer to ensure that election is conducted in proper manner.
- B) Notice of Election will be declared, via a separate communication, 14 days in advance mentioning dates of accepting / withdrawal of nomination form and date of election.
- C) Rules of Election :  
Member industries, who have paid Annual Subscription upto and including year 2023-24 will only be eligible to contest the election. Each eligible member industry will contest maximum one seats at a time. Every member industry can vote for maximum of 11 members.
- D) Nomination Form has to be collected by the concerned member industry, either by mail or from PRIA Office or it will be available in downloads at our website i.e. [www.pria-patalganga.com](http://www.pria-patalganga.com) and submit the same physically in the office by 6.00 pm on April 19, 2024.
- E) Member industry forwarding nomination form as well as member industry seconding that nomination must have paid Annual Subscription upto year 2023-24, to be eligible.

- Further, in the absence of consensus, the office bearers will be elected by secret ballot amongst the elected Members.
- H) Mr. Dilip R. Kadam, Associate Manager, working at Thermax Ltd, Patalganga has been nominated as Returning Officer for conducting the election.
